### FAIRY Home Sukkur was established in May 2018

Farzana Fairy Home (A Project of Farzana Welfare Organization (Regd) Non-Governmental Organization), the first and only of its kind in Pakistan, founded in May 2018, undertook to give shelter and sustenance to the orphans, helpless girls and women of whole the country, under the chairpersonship and under the aegis of advocate Farzana Khoso, hailing from tribal area of District Kashmore, an area differing each and every social and human freedom, an area notorious for the extortion and exploitation of the girls and women.

Being rebel to the inhuman and merciless treatment with the girls and the women in this area, Advocate Farzana Khoso, pursuing her respected father Dr. Abdul Razaque Khoso and Late Abdul Sattar Eedhi, embarked on social services and organized Farzana Welfare Association cherishing the dreams to shelter and support the helpless and hapless girls and women of our area. As an advocate she always remained on front in supporting the destitute and the deprived legally and financially yet to continue her mission successively, more efficiently and more competently, she established an exceptional and outstanding institution namely Fairy Home in Sukkur, for the complete shelter and sustenance of the girls and women and made wonders and made history in the world of selfless services of society.

Honorable Farzana Khoso has a vision to establish such Fairy Homes all over Sindh in immediate future so that no helpless girl and woman of the society may feel herself alone and be exploited, suppressed or subjugated.

# THE FACILITIES AND AMENTIES PROVIDED BY THE FAIRY HOME SUKKUR.



- Each room provides separate bed for each girl/woman living together in family atmosphere.
- Each room is supervised and serviced by a mother (Aaya).
- Careful and cautious arrangement for the extra-curriculum activities i-e Games, Sports,
   Picnics etc.
- Time and again Awareness lectures on how to help one another.
- Acquisition of standard education from the renowned educational institution.
- After school Tuitions.
- Health services and fortnightly visits from the specialist doctors.
- Centre of vocational training.
- Beautician Classes in evening timing
- Three times Healthy diet in excellent hygienic environment.
- 24 Hours high security with the all-around equipped CCTV Cameras.
- Honor for self-respect
- Religious freedom and respective religious education.
- School for children and stand-by vehicles in case of any emergency.
- Full attention to teaching etiquettes, manners and morals.
- Fulfilment of the needs of the clothes, home articles.

#### **Objective Aims and Goals**

- Provision of protection and support.
- Provision of healthy environment.
- Summits and seminars for spiritual, psychological, and perceptual awareness.
- Making children aware of their rights to eat good, acquiring good education, and living a quality life.
- Giving personal attention to every child.
- To make children aware of leading their lives according to their faith, wishes and will.
- Making the children intellectually sensible.
- Providing basic education and vocational training on daily basis.
- To change them to become perseverant and persistent in their lives' goals.
- Dispelling the thoughts of loneliness, inferiority from within the children.
- Making children active, responsible and good citizens.
- Creating opportunities for the children to meet their relatives.
- Calling the orphan child a Fairy by substituting the name "Orphan/Yateem)



### **Targets Group**

Following procedure will be applied for admission of orphan children to the Fairy Home in addition to providing the family environment and basic education.

- The orphans deprived of the parents.
- The poor living life below the poverty line.
- No age restrictions.
- Solitary and lonely children.
- Children avoided living with their families for certain reasons.
- Children of the prisoner women, until their relative take their custodies.



#### **Criterion for Admission**

All children are eligible for admission with respect to the Target Group with no consideration of age, however on the recommendations and through the source of government, non-government, or any Other reliable persons of society. The children will be kept in the Fairy Home till the completion of their education, vocation training or their wedding.



### **Proceeding for Admission**

Parents of the "fairies" can apply for the admission through prescribed application form (available at the In-charge office of the Fairy Home Sukkur), Along with the required documents including the birth certificate, Death certificate of the parent(s), Stamp Paper of rupees 50, signed by the deponent and two witnesses and mandatorily attested by honorable Justice of Peace. After the necessary scrutiny the CEO FAIRY HOME SUKKUR will offer admission to the candidate.

The in-charge FAIRY HOME SUKKUR is responsible for the maintenance of records of the admitted child with a view to the future and career of the child in her life ahead.

Absolute authority of acceptance or rejection of the application forms for admission of candidate is vested with honorable chairperson Farzana Khoso



# **Facilities**

The under-mentioned facilities are provided to the child by the fairy home.

- Free accommodation in family environment.
- Complete balanced diet on weekly menu of the diet plan.
- Free education from and through the renowned schools.
- Free uniforms, course books and required utensils.
- Free summer and winter clothes along with shoes.
- Free health care and treatment from the government and non-government hospitals.
- Free washing and ironing of the clothes.
- Respective places of worship and religious education.
- Free Beautician Classes
- Awareness lectures.


