Child Safeguarding Policy

1. Policy Statement

Fairy Home is committed to safeguarding the welfare, dignity, and rights of every girl in its care. We believe all children have the right to be protected from abuse, neglect, exploitation, and violence. We uphold the principle that child protection is everyone's responsibility and commit to creating a safe, supportive, and nurturing environment for all our residents.

2. Purpose of the Policy

This policy is intended to:

- Ensure the safety and well-being of all girls residing at Fairy Home.
- Prevent any form of abuse or harm within the shelter.
- Guide staff, volunteers, visitors, and stakeholders in recognizing and responding to safeguarding concerns.
- Establish procedures for reporting and responding to incidents or suspicions of abuse.

3. Scope of the Policy

This policy applies to:

- All staff members (full-time, part-time, temporary)
- · Volunteers and interns
- · Visitors, donors, and contractors
- Partner organizations working within or alongside Fairy Home







4. Guiding Principles

- Best Interests of the Child: The well-being and rights of the child are our top priority in all decisions and actions.
- Zero Tolerance of Abuse: Any form of abuse, neglect, or exploitation will not be tolerated.
- Child Participation: Girls have the right to be heard and to participate in decisions affecting their lives.
- Non-Discrimination: All children are treated equally, regardless of age, race, religion, disability, or background.
- Confidentiality: Child protection concerns will be handled with the highest level of confidentiality.

5. Definitions of Abuse

- · Physical Abuse: Intentional use of force resulting in injury or harm.
- Emotional Abuse: Acts that harm a child's emotional well-being and development.
- Sexual Abuse: Any sexual activity with a child, including grooming or exploitation.
- Neglect: Failure to provide necessary care, supervision, or protection.
- Bullying and Harassment: Repeated aggressive behavior intended to hurt or intimidate

6. Roles and Responsibilities: Management:

- Ensure policy implementation and monitoring.
- · Provide training and resources.



Appoint a Child Protection Officer (CPO).

Child Protection Officer (CPO):

- Act as the focal point for all safeguarding concerns.
- Maintain documentation of incidents and responses.
- Liaise with authorities when required.

Staff and Volunteers:

- · Know and follow the policy.
- Attend safeguarding training sessions.
- · Report concerns promptly to the CPO.

7. Safe Recruitment Practices

Fairy Home (FMWO) will ensure:

- Background checks (including police clearance) are conducted for all staff and volunteers.
- · Reference checks are completed before hiring.
- Child safeguarding responsibilities are included in job descriptions.

7. Code of Conduct

All individuals working with children at Fairy Home must:

- · Treat children with respect and dignity always.
- Avoid being alone with a child in private settings.
- Not engage in inappropriate physical contact.







- Not using language or behavior that is abusive, aggressive, or sexually suggestive.
- Report any observed or suspected abuse immediately.

Process of Formation of Protection and Safeguarding Committee

2. Need Identification

- The concerned authority (e.g., school, organization, or local government) recognizes the need for a committee to ensure the safety and protection of children, women, or vulnerable groups.
- This may be based on legal mandates, incidents, audits, or policy requirements.

3. Official Notification

- A formal notification or circular is issued by the competent authority (e.g., principal, head of department, district officer).
- The notification outlines the purpose, scope, and responsibilities of the committee.

4. Selection of Members

- Members are carefully chosen based on their roles, experience, and commitment to safeguarding.
- o The committee typically includes:
 - A Chairperson (usually a senior official or head of institution)
 - Designated Protection Officer / Counselor
 - Teachers / Staff representatives (if in a school)
 - Parent representatives
 - Community members / NGO representatives (optional)







- Legal or child rights experts (as needed)
- Student or youth representatives (in ageappropriate settings)

5. Roles and Responsibilities Defined

- Specific roles and duties are assigned to each member.
- o The responsibilities may include:
 - · Monitoring and reporting abuse or neglect
 - Creating awareness about safety and rights
 - · Conducting regular meetings and audits
 - Ensuring compliance with protection laws and policies
 - Maintaining confidentiality and a survivorcantered approach

6. Training and Capacity Building

- All members are provided with training on:
 - Child protection laws (like POCSO)
 - Gender sensitization
 - Handling complaints ethically and legally
 - Emergency response protocols

7. Formation of SOPs and Reporting Mechanisms

- The committee develops clear Standard Operating Procedures (SOPs) for handling complaints or safeguarding concerns.
- Suggestion/complaint boxes, helplines, or online reporting systems may be established.







8. Awareness and Communication

- The existence and purpose of the committee are widely communicated to all stakeholders (e.g., students, employees, parents, community).
- Awareness programs, posters, workshops, and meetings are organized.

9. Regular Monitoring and Review

- The committee meets at regular intervals (monthly, quarterly, or as needed).
- Reviews past incidents, actions taken, and suggests improvements in safety protocols.
- Submit reports to higher authorities as required.

10. Renewal and Restructuring (if needed)

- The composition of the committee is reviewed annually.
- Members may be rotated or replaced to ensure fresh perspectives and commitment.

9. Reporting and Responding to Concerns

- Any suspicion, disclosure, or allegation of abuse must be reported to the CPO immediately.
- The CPO will assess the situation and decide on the next steps, including:
 - Speaking with the child in a safe, private, and nonleading manner.
 - Notifying shelter management.
 - Reporting to appropriate child protection authorities, if necessary.

Fairy Home (FMWO) will support victims, protect whistleblowers, and take disciplinary actions against perpetrators.

10. Training and Awareness

- All staff and volunteers will receive induction and annual refresher training on child safeguarding.
- Children will be educated on their rights, personal safety, and how to report abuse.

11. Monitoring and Review

This policy will be reviewed annually or after any incident to ensure its effectiveness and relevance. Feedback from children, staff, and partners will be incorporated into reviews.
